NEPTUNE REX through his trusty shellbacks, that the good ship U.S.S. HOPE is about to enter these waters and manned by a crew who has not acknowledged the sovereignty of the Ruler of the Deep, has transgressed on his domains and thereby incurred his Royal Displeasure

THEREFORE be it known to all ye Box Car Tourists, Hitch Hikers, Hay Makers, Plow Deserters, Beach Warmers, Sea Lawyers, Beach Combers, Land Lubbers and Politicians that His Most Royal Highness NEPTUNE REX, Supreme Ruler of all mermaids, sharks, squibs, crabs, polly-wogs, eels and other denizens of the deep, will, with his Secretary and Royal Court, meet in full session on board the offending ship-
